

## Disbursements

Disbursements are the fees which we pay (on your behalf) in order to secure the services provided by third parties in order to carry out the funeral. These will most often include some or all of the following: Doctor's fees; Celebrant's fees; Cemetery charges; Crematorium fees, a post-funeral reception and such like.

The disbursements are added to our charges set out on the previous page and the coffin price in order to arrive at the final funeral charge.

In order to ensure these services can be secured in line with your desired timescale, we ask that payment of the disbursements is made in full at the time of arranging the funeral.

## Direct cremation service

This basic service consists of collection of the body, arrangement of cremation papers, storage of the body, an unlined coffin, hearse direct to the crematorium, no service at the crematorium, a simple ashes casket and return of ashes.

This is a fixed price service that allows you the freedom to hold a funeral or celebration of life as and when you choose. There would be no ceremony on the day of the cremation.

## What to do now

If you have not already done so, you must make an appointment to register the death with the Registrar of Births, Deaths and Marriages. We can arrange an appointment for you and will happily assist in transporting you to and from the Registrars' offices.

When you attend the appointment, you will be asked for:

- The medical certificate.
- The deceased person's medical card.
- Any benefit books.
- The deceased person's marriage certificate, if there is a surviving spouse.

You will also be asked the following information about the deceased person:

- First name, surname and any maiden name.
- Date and place of death.
- Last permanent address.
- Date and place of birth (a copy of their birth certificate is helpful).
- Occupation and name/occupation/date of birth of any surviving spouse.
- Details of benefit being claimed, including state and private pension income.

The registrar will issue you a death certificate. If the deceased person had financial dealings with a number of organisations including banks, building societies and insurance companies, you may find it useful and cheaper to obtain several additional copies. Many companies will require a certified copy of the death certificate when they are advised of the death.
